Minor child has been removed from his home after his mother requested placement by WCHSA. Child is special needs with developmental delays, autism, ADHD, and possible traumatic brain injury. Child is in need of special care and services that mother has failed to be able to provide. Mother is aware of, and has reported, physically and sexually inappropriate behavior on the part of the client toward his other younger siblings. She reports reaching out to multiple institutions for help with his behavioral issues and has received no help. Renown turned her away and she claims SRC was non-responsive and failed to follow through with any services. Mother fears for the safety of her other children after home surveillance videos were viewed showing inappropriate physical and sexual behavior toward younger sibling. Client's father is incarcerated and therefore cannot contribute to the care and well-being of client. Father has not maintained communication or visitation since being incarcerated.

Child was removed from parental custody by WCHSA on Sept. 2, 2021. Removal occurred after mother was arrested for child endangerment and DUI. Mother was involved in a vehicle accident with child in the car because of alcohol consumption. Mother admits to having no memory of the evening or event due to intoxication. Father is unable to care for child due to lack of stable housing or income. Father also has no current relationship with child.

Mother obtained minimal prenatal care during pregnancy. On Sept. 12, 2021, hospital staff found drug paraphernalia in hospital room belonging to mother. Mother was arrested on Sept. 14, 2021 for possession of heroine and outstanding warrant. Mother has continued to use despite being referred to multiple substance abuse programs. Mother has no family or friends who are able to assist with proper care of the child.
